

RESOLUTION 80-2018

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE SPECIAL ELECTION HELD IN THE CITY OF ABILENE ON MAY 5, 2018.

WHEREAS, That on the 8th day of February 2018, the City Council of the City of Abilene, through adoption of Resolution No. 15-2018, ordered a Special election to be held in said City on the 5th day of May, 2018, in accordance with the provisions of the Charter of said city, for the purpose of providing for a non-binding referendum for voter consideration of street maintenance fees; and

WHEREAS, That the city council after having duly examined the Unofficial Special Election Returns submitted by Taylor County finds that it is a true and correct tabulation of the election results; that the election held on May 5, 2018 was duly ordered and notice given in accordance with law; that the election was held in the manner required by law; that only duly qualified resident voters of the city of Abilene voted in the election; and that returns of the election have been made by the proper officers; and

WHEREAS, That the canvass and tabulation of votes cast at the election held May 5, 2018, discloses that the proposition received a majority of the votes cast in favor of the proposition:

Do you support the creation of a street maintenance fee for the purpose of repairing and maintaining City streets?

55.59% VOTES FOR

44.41% VOTES AGAINST

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:


